I. CALL TO ORDER

II. ADMINISTRATIVE REVIEW OF PREVIOUS ACTIONS

1. 14-52: In Re: Margaret Sorensen, D.V.M. Board may review, discuss, and take action on Continuing Education plan as required by Board Order.

After discussion and consideration, a motion was made by Dr. Serbin and seconded by Ms. Young to approve Dr. Sorenson's continuing education plan submitted in compliance with her Board Order. Motion passed unanimously.

2. 14-48: In Re: Christina Barber, D.V.M. Board may review, discuss, and take action on submission of completion of Continuing Education as required by Board Order.

After discussion and consideration, a motion was made by Dr. Christensen and seconded by Dr. Hatfield to approve Dr. Barber's continuing education in compliance with her Board Order and return her license to Active status. Motion passed unanimously.

c. Lystra Lloyd, D.V.M.

After discussion and consideration, a motion was made by Dr. Serbin and seconded by Ms. Gullett to **approve** Dr. Lloyd's renewal application. Motion passed unanimously.

d. Jim Rusher, D.V.M.

Dr. Hatfield was recused. After discussion and consideration, a motion was made by Dr. Serbin and seconded by Ms. Gullett to open a complaint and offer Dr. Rusher a Consent Agreement for violating **A.R.S. § 32-2218(A)** as it relates to **R3-11-401(A)** for failure to complete any continuing education required to renew his veterinary license. The Consent Agreement is to include a period of Probation for six (6) months to allow Dr. Rusher to complete the 20 hours of continuing education required for the renewal of his 2015-2016 veterinary license. Motion passed 6 ayes, 1 recusal.

e. Chris Simpson, D.V.M.

After discussion and consideration, a motion was made by Dr. Serbin and seconded by Ms. Gullett to open a complaint and offer Dr. Simpson a Consent Agreement for violating **A.R.S. § 32-2218(A)** as it relates to **R3-11-401(A)** for failure to complete 13 of the 20 hours of continuing education required to renew his veterinary license. The Consent Agreement is to include a period of Probation for six (6) months to allow Dr. Simpson to complete the remaining 13 hours of continuing education required for the renewal of his

2015-2016 veterinary license. Motion passed unanimously.

After discussion and consideration, a motion was made by Dr. Serbin and seconded by Ms. Young to open a complaint and offer Dr. Gorman a Consent Agreement for violating **A.R.S. § 32-2218(A)** as it relates to **R3-11-401(A)** for failure to complete 7 of the 20 hours of continuing education required to renew her veterinary license. The Consent Agreement is to include a period of Probation for six (6) months to allow Dr. Gorman to complete the remaining 7 hours of continuing education required for the renewal of her 2015-2016 veterinary license. Motion passed unanimously.

Motion passed unanimously.

The Consent Agreement is to include a **civil penalty** of \$25.00. Motion passed unanimously.

b. Brandy Caldwell-Bakken, C.V.T.

After discussion and consideration, a motion was made by Dr. Serbin and seconded by Ms. Gullett to open a complaint and offer Ms. Berger a Consent Agreement for violating **A.R.S. § 32-2246** as it relates to **R3-11-401 (D)** for failure to complete 10 hours of continuing education in the two-year period preceding certification expiration as required to renew her certificate. The Consent Agreement is to include a **civil penalty** of \$25.00. Motion passed unanimously.
