**MINUTES**

#### I. CALL TO ORDER

Roll call: Ms. Whitmore at 8:40 a.m.

### II. INITIAL INVESTIGATIVE REVIEW AND ACTION ON THE FOLLOWING CASES:

#### 1. 20-87, In Re: Virginia Kern, DVM

Attorney David Stoll was present to monitor. Ms. Jessica Detweiler was present telephonically and made statements.

- > At 9:21 a.m., after discussion and consideration, a motion was made by Ms. Creager and seconded by Dr. Jaynes to go into executive session for legal advice. Motion passed unanimously.
- > At 9:35 a.m., the Board entered back into open session.

After discussion and consideration, a motion was made by Dr. Jaynes and seconded by Dr. Wright to offer Dr. Kern a **Consent Agreement** and adopt the Investigative Committee's Findings of Fact as the Board's Findings of Fact and modify the Investigative Committee's Conclusion of Law finding Dr. Kern in violation of:

- A.R.S. § 32-2232 (21) as it relates to AAC R3-11-502 (L) (4) failure to perform an exam on the dog prior to staff administering a vaccine;
- A.R.S. § 32-2232 (18) as it relates to AAC R3-11-501 (8) failure to provide a copy of the dog's necropsy report to the pet owner within 10 days after request; and
- A.R.S. § 32-2232 (11) gross negligence: failure to perform an exam on the dog to investigate the cause of the dog's vomiting before instructing staff to administer multiple

doses of milk of bismuth; Respondent also exhibited professional misconduct for failing to call the emergency contact left by the pet owner when the dog was showing signs of distress.

Roll call: Dr. Jaynes, aye; Mr. Loughead, aye; Dr. Wright, aye; Ms. Soloman, aye; Ms. Creager, aye; Ms. Frost, aye; and Dr. Heinrich, aye. Motion passed unanimously.

After further discussion and consideration, a motion was made by Dr. Jaynes and seconded by Ms. Creager to offer Dr. Kern a Consent Agreement to include an agreement to not renew her veterinary license this renewal cycle (license expires 12/31/2020); not to personally accept new patients; and notify existing clients, in writing, that she will no longer be practicing veterinary medicine after the first of the year and will advise the Board when this occurs. If Dr. Kern does not sign the Consent Agreement, the matter will be moved to Formal Hearing for possible revocation of licensure.

Roll call: Dr. Jaynes, aye; Mr. Loughead, aye; Dr. Wright, aye; Ms. Soloman, nay; Ms. Creager, aye; Ms. Frost, aye; and Dr. Heinrich, aye. Motion passed 6 ayes, 1 nay.

#### 2. 20-92, In Re: Ayman Wassef, DVM

Attorney David Stoll was present to monitor. Dr. Daniel Jacoby was present telephonically and made statements. After discussion and consideration, a motion was made by Dr. Wright and seconded by Ms. Soloman to schedule this matter to an **Informal Interview**. Motion passed 6 ayes, 1 nay (Mr. Loughead).

#### 3. 20-93, In Re: Kira Zerkel, DVM

Ms. Frost was recused. Attorney David Stoll was present to monitor. After discussion and consideration, a motion was made by Dr. Jaynes and seconded by Ms. Creager to accept the Investigative Committee's recommendation and **dismiss** this issue with no violation. Roll call: Dr. Jaynes, aye; Mr. Loughead, nay; Dr. Wright, aye; Ms. Soloman, aye; Ms. Creager, aye; Ms. Frost, recused; and Dr. Heinrich, absent. Motion passed 4 ayes, 1 nay, 1 absent, and 1 recusal.

After further discussion and consideration, a motion was made by Dr. Jaynes and seconded by Ms. Soloman to **open an investigation** regarding the responsible veterinarian for the premises, Dr. Shantibhushan Jha, with respect to allegedly allowing non-veterinary staff to diagnose animals. Motion passed 5 ayes, 1 recusal (Ms. Frost) and 1 absent (Dr. Heinrich).

#### 4. 20-94, In Re: Sarah Carotenuto, DVM

Attorney David Stoll was present to monitor. After discussion and consideration, a motion was made by Dr. Wright and seconded by Ms. Creager to accept the Investigative Committee's recommendation and **dismiss** this issue with no violation. Motion passed 6 ayes, 1 absent (Dr. Heinrich).

### 5. 20-95, In Re: Katheryne Kasper, DVM

Attorney David Stoll was present to monitor. After discussion and consideration, a motion was made by Ms. Creager and seconded by Ms. Soloman to accept the Investigative Committee's recommendation and **dismiss** this issue with no violation. Motion passed 6 ayes, 1 absent (Dr. Heinrich).

Roll call: Dr. Jaynes, aye; Mr. Loughead, aye; Dr. Wright, nay; Ms. Soloman, nay; Ms. Creager, aye; Ms. Frost, aye; and Dr. Heinrich, aye. Motion passed 5 ayes, 2 nays.

# III. INFORMAL INTERVIEWS - BOARD DELIBERATION AND ACTION

### 1. 20-79: In Re: Megan Helgeson, DVM

Dr. Helgeson was present with attorney David Stoll, made statements and answered questions. Attorney Tricia Schafer was present telephonically; Mrs. Lisa Kravetz and Ms. Brookelyn Kravetz were present telephonically, made statements and answered questions. Dr. Stacy Duffy was present telephonically. After discussion and consideration, a motion was made by Dr. Jaynes and seconded by Dr. Heinrich to **dismiss** this issue with no violation. Roll call: Dr. Jaynes, aye; Mr. Loughead, aye; Dr. Wright, nay; Ms. Soloman, nay; Ms. Creager, aye; Ms. Frost, aye; and Dr. Heinrich, aye. Motion passed 5 ayes, 2 nays.

### 2. 20-83: In Re: Hugo Santibanez, DVM

Dr. Santibanez was present with attorney, Logan Elia, made statements and answered questions. Ms. Annabell Gonzalez was present, made statements and answered questions. After discussion and consideration, a motion was made by Dr. Jaynes and seconded by Ms. Soloman to find Dr. Santibanez in violation of:

A.R.S. § 32-2232 (12) as it relates to AAC R3-11-501 (1) failure to provide current professional and scientific knowledge by not providing a complete evaluation of the dog, especially with respect to the eyes; not recommending a urinalysis due to the increased thirst and urination; and not offering IV or SQ fluids to a dog that was 10% dehydrated. Fluids would not have been detrimental in animal with a HCT of 22 %.

Roll call: Dr. Jaynes, aye; Mr. Loughead, nay; Dr. Wright, nay; Ms. Soloman, aye; Ms. Creager, aye; Ms. Frost, aye; and Dr. Heinrich, absent. Motion passed 4 ayes, 2 nays and 1 absent.

3. 20-72: In Re: Jolene Conley, DVM — Continuance of Informal Interview of September 16, 2020, for the purpose of receiving additional information and reviewing possible action to approve proposed Findings of Fact, Conclusions of Law, and adopting an Order.

Attorney David Stoll was present to monitor. After discussion and consideration, a motion was made by Dr. Wright and seconded by Ms. Soloman to adopt the Findings of Fact and Conclusions of Law as drafted. Motion passed 6 ayes, 1 absent (Dr. Heinrich).

After further discussion and consideration, a motion was made by Dr. Wright and seconded by Ms. Soloman to issue Dr. Conley an Order that includes a period of **Probation for 1-year** to obtain **three (3) hours of continuing education**, in addition to the statutory requirements to maintain licensure. Those three (3) hours are to be in **fungal disease and treatment**. Roll call: Dr. Jaynes, aye; Mr. Loughead, aye; Dr. Wright, aye; Ms. Soloman, aye; Ms. Creager, aye; Ms. Frost, aye; and Dr. Heinrich, absent. Motion passed 6 ayes, 1 absent.

4. 20-76: In Re: Lyle Robinson, DVM – Continuance of Informal Interview of September 16, 2020, for the purpose of receiving additional information and reviewing possible action to approve proposed Findings of Fact, Conclusions of Law, and adopting an Order.

Attorney David Stoll was present to monitor. After discussion and consideration, a motion was made by Dr. Jaynes and seconded by Ms. Soloman to adopt the Findings of Fact and Conclusions of Law as drafted. Motion passed 6 ayes, 1 absent (Dr. Heinrich).

After further discussion and consideration, a motion was made by Dr. Jaynes and seconded by Dr. Wright to issue Dr. Robinson an Order to include a period of **Probation for 1-year** to obtain four **(4) hours of continuing education**, in addition to the statutory requirements to maintain licensure. Those four **(4)** hours are to be in:

- Two (2) hours CE in anesthesia; and
- Two (2) hours CE in medical record keeping.
