II. INITIAL INVESTIGATIVE REVIEW AND ACTION ON THE FOLLOWING CASES

After discussion and consideration, a motion was made by Dr. Thompson and seconded by Dr. Wright to reject the Investigative Committee's recommendation and **dismiss** this issue with no violation. Motion passed unanimously.

R3-11-201 (A) (3)** failure to pay her veterinary application and issuance fees. Motion passed unanimously.

After further discussion and consideration, a motion was made by Mr. Loughead and seconded by Ms. Soloman to offer Dr. Muniga a Consent Agreement that includes a **civil penalty of \$500**, which would cover her veterinary application and issuance fees. III. INFORMAL INTERVIEWS - BOARD DELIBERATION AND ACTION

R3-11-501 (1)** failure to follow professionally acceptable procedures and use current professional and scientific knowledge for not considering further diagnostics when the results of the blood work was done on June 9, 2022 and not discussing the results of the urinalysis after it was eventually performed. Motion passed unanimously.

2. 23-27: In Re: Rose Ann Fiskett, VMD – Continuance of Informal Interview of March 15, 2023, for the purpose of receiving additional information and reviewing possible action to approve proposed Findings of Fact, Conclusions of Law, and adopting an Order.

After discussion and consideration, a motion was made by Dr. Jaynes and seconded by Mr. Loughead to accept the Findings of Fact and Conclusions of Law as drafted and issue Dr. Fiskett an Order that includes a period of **Probation for 1-year** to obtain an additional three **(3) hours of continuing education** in addition to the statutory requirements to maintain licensure; those three (3) hours shall be in the area of **properly assessing a pet's condition. This can include basic physical examination; cardiac auscultation and risk assessment; and/or anesthesia risk assessment.** The Order shall also include a **civil penalty of \$500** to be paid on or before the end of the Probationary period.
