I. CALL TO ORDER

Roll call: Ms. Victoria Whitmore at 8:30 a.m.

II. INITIAL INVESTIGATIVE REVIEW

1. 16-36, In Re: Donald DeShazer, DVM.

Attorney, David Stoll, was present to monitor. After discussion and consideration, a motion was made by Dr. Hatfield and seconded by Ms. Amend to accept the Investigative Committee's recommendation and **dismiss** this matter with no violation. Motion passed unanimously.

2. 16-37, In Re: Carlton Huilt Jr, DVM.

Attorney, David Stoll, was present to monitor. After discussion and consideration, a motion was made by Dr. Wright and seconded by Ms. Amend to accept the Investigative Committee's recommendation and **dismiss** this matter with no violation. Motion passed unanimously.

3. 16-38, In Re: ShanAnne Edwards, DVM.

Attorney, David Stoll, was present to monitor. Ms. Joy Hollander and Mr. James Babcock were present and made statements. After discussion and consideration, a motion was made by Ms. Amend and seconded by Ms. Frost to accept the Investigative Committee's recommendation and **dismiss** this matter with no violation. Motion passed unanimously.

4. 16-39, In Re: Stephanie Foote, DVM.

Attorney, David Stoll, was present to monitor. Ms. Aliza Dodell was present and made statements. After discussion and consideration, a motion was made by Dr. Wright and seconded by Dr. Heinrich to issue Dr. Foote a **Letter of Concern** for not clearly communicating possible anesthetic risks to the pet owner. Motion passed unanimously.

5. 16-40, In Re: Mindy Bemmerl, DVM.

Attorney, David Stoll, was present to monitor. After discussion and consideration, a motion was made by Dr. Byrne and seconded by Dr. Wright to accept the Investigative Committee's recommendation and **dismiss** this matter with no violation. Motion passed unanimously.

III. INFORMAL INTERVIEWS AND BOARD DELIBERATION

1. 16-27: In Re: Connie Sanders, DVM.

Ms. Frost was recused. Dr. Sanders was present with counsel, David Stoll, made statements and answered questions. Ms. Maria Bux was present, made statements and answered questions. After discussion and consideration, a motion was made by Ms. Young and seconded by Dr. Hatfield to issue Dr. Sanders a **Letter of Concern** regarding the timeliness of acute cardiovascular treatment and pain management for acute bloat. Motion passed 7 ayes, 1 recusal.

2. 16-28: In Re: Della Gregory-MacDonald, DVM.

Ms. Frost was recused. Dr. Gregory-MacDonald was present with counsel, David Stoll, made statements and answered questions. Ms. Maria Bux was present, made statements and answered questions. After discussion and consideration, a motion was made by Dr. Wright and seconded by Ms. Amend to **dismiss** this matter with no violation. Motion passed 7 ayes, 1 recusal.

After further discussion and consideration, a motion was made by Dr. Wright and seconded by Mr. Loughhead to open an investigation regarding the premise license holder of Prescott Area Pet Emergency Hospital. Motion passed 6 ayes, 1 nay (Dr. Hatfield), 1 recusal.

3. 16-26: In Re: Laura Harris, DVM.

Dr. Byrne was recused. Dr. Harris was present with attorney, Michael Beethe, made statements and answered questions. Dr. Harry Switzer and Ms. Joanne Switzer were present, made statements and answered questions. Janet Hanes and Dianne Maden were present, made statements and answered questions. After discussion and consideration, a motion was made by Dr. Hatfield and seconded by Dr. Wright to find Dr. Harris in violation of:

- o **A.R.S. § 32-2232 (21)** as it relates to **A.A.C. R3-11-502**:
 - **(L)(2)** failure to document the dog's weight in the medical record on 8/5/2015 and 9/17/2015; and
 - **(L)(4)** failure to document the dog's temperature, heart rate and respiration rate in the medical record on 8/5/2015 and 9/17/2015.
- o **A.R.S. § 32-2232 (12)** as it relates to **A.A.C. R3-11-501 (3)** failure to offer a referral when the animal's condition was not improving or declining.

- o **A.R.S. § 32-2232 (12)** as it relates to **A.A.C. R3-11-501 (1)** failure to provide professionally acceptable procedures for: (1) the Respondent's dosing regarding the aspirin; (2) lack of proper communication regarding aspirin therapy and the cessation of getting it; and (3) documenting that recommendation on the invoice and for not obtaining a proper physical exam and proper diagnostics for an ill patient.

Roll call: Dr. Hatfield, aye; Ms. Frost, aye; Ms. Young, aye; Dr. Heinrich, aye; Ms. Amend, aye; Mr. Loughhead, aye; Dr. Wright, aye. Motion passed 7 ayes, 1 recusal (Dr. Byrne).

4.16-19: In Re: Michael Ferrera, DVM. Continuance of Informal Interview of March 16, 2016, for the purpose of receiving additional information and reviewing and possible action to approve proposed Findings of Fact, Conclusions of Law and adopting an Order.

After discussion and consideration, a motion was made by Dr. Byrne and seconded by Ms. Amend to accept the proposed Findings of Fact and Conclusions of Law as drafted. Motion passed unanimously.

After further discussion and consideration, a motion was made by Dr. Hatfield and seconded by Ms. Young to issue Dr. Ferrera an Order that includes a period of **Probation** for one **(1) year** to obtain **6 hours** of continuing education in communication/ethics in addition to the statutory requirements for license renewal. The Order shall also include a **\$500 civil penalty** to be paid before the end of the probationary term.

IV. ADMINISTRATIVE REVIEW OF PREVIOUS ACTIONS

1. 14-27, In Re: Monica Bunge, DVM. Quarterly Board appearance in compliance with Consent Agreement.

Dr. Bunge was present telephonically, made statements and answered questions in compliance with her Consent Agreement.

2. 15-85, In Re: Clayton Wengert, DVM. Board may review, discuss, and take action on compliance with Board Order.

After discussion and consideration, a motion was made by Ms. Amend and seconded by Dr. Wright to open an investigation regarding Dr. Wengert's non-compliance of Board Order 15-85 and move it directly to an informal interview. Motion passed unanimously.

3.15-10, In Re: Refaat Ishak, DVM. Board may review, discuss, and take action on completion of continuing education completed as required by Board Order.

After discussion and consideration, a motion was made by Ms. Amend and seconded by Dr. Heinrich to accept Dr. Ishak's continuing education completed as required by his Board Order. Motion passed unanimously.

4.15-77 & 15-103: In Re: Refaat Ishak, DVM. Board may review, discuss, and take action on final Board Order.

Assistant Attorney General, Michael Raine, was present to provide independent procedural advice to the Board.

After discussion and consideration, a motion was made by Dr. Hatfield and seconded by Ms. Amend to rescind their original motion with respect to Dr. Ishak's Board Order sanctions. Roll call: Dr. Hatfield, aye; Ms. Frost, aye; Ms. Young, aye; Dr. Heinrich, aye; Ms. Amend, aye; Mr. Loughhead, aye; Dr. Wright, aye and Dr. Byrne, aye. Motion passed unanimously.

After further discussion and consideration, a motion was made by Dr. Hatfield and seconded by Dr. Wright issue Dr. Ishak an Order to include a period of **Suspension for six (6) months**; the Order shall include a **Stayed Revocation** during that time. During the period of Suspension, Dr. Ishak shall take, and pass, the NBVE companion animal species specific exam; he will have two attempts to successfully pass the exam. If Dr. Ishak does not pass the exam, the Stayed Revocation shall be lifted and Dr. Ishak's veterinary license will be revoked.

If Dr. Ishak passes the NBVE exam, after the period of Suspension, Dr. Ishak's veterinary license will be placed on **Probation for 5-years** to obtain an additional **100 hours of continuing education**, in addition to the statutory requirements for licensure, in the area of:

- Anatomy and physiology;
- Surgery; and
- Diagnostics.

50 of the 100 hours of continuing education shall be obtained by attending wet labs with 35 of the 50 hours in soft tissue and/or orthopedic surgeries. If a continuing education course/institution requires a test, Dr. Ishak must pass the test based on the institution's grading system.

Dr. Ishak shall submit to the Board for approval at least twenty (20) hours of his continuing education plan within 6-months of the effective date of the Order, and at least twenty (20) hours each year after that.

Dr. Ishak shall pay a **civil penalty** of **\$3000** by the end of the Probation period.

Additionally, Dr. Ishak shall be **restricted from performing and any and all surgeries indefinitely, including soft tissue, orthopedics and oral surgeries, including extractions**. Prior to termination of the practice restriction, Respondent must submit a written request to the Board for release or modification of the practice restrictions outlined in the Order. When submitting such a request, Respondent shall provide the Board with evidence establishing that he has appropriately addressed the issues that resulted in the practice restrictions and he can safely and competently perform surgical procedures.

During the 1st year of the Probationary period, Dr. Ishak shall submit fifteen (15) sets of medical records quarterly to assist the Board in evaluating Dr. Ishak's competency.

If Dr. Ishak employs an associate or relief veterinarian, the associate or relief veterinarian shall read the Order and submit a written notice to the Board that he/she understands the terms of Dr. Ishak's Order. The same is true if Dr. Ishak is employed by any other premise other than his own.

Also, the Order shall include a Stayed Suspension. If Dr. Ishak has engaged in practice outside the restrictions, the Stayed Suspension shall be lifted and Dr. Ishak's license will be

suspended until a hearing can be held.

Ms. Whitmore reported that HB250, dealing with the merging of many health care boards with the Department of Health Services, had been withdrawn from its sponsor; HB2613, which contains a provision for ADOA to conduct a study of transferring all non-health boards to ADOA has been retained in the Senate; HB2337, which provides minor modifications to site inspection requirements passed both houses; HB2517, called the "Right to Earn a Living Act," was passed by the Senate Government Committee.

b. American Association of Veterinary State Boards (AAVSB) Member Boards' Executive Committee and Board nomination update

Ms. Whitmore stated that Dr. Brian Serbin had withdrawn his acceptance of the nomination to the AAVSB Board of Directors due to time commitments. She further shared that she serves as the AAVSB Conference Committee Chair and has been asked by the AAVSB Board to serve on a new Executive Directors Advisory Committee.
