## **I. CALL TO ORDER**

**Roll call:** Ms. Victoria Whitmore.

## **II. INITIAL INVESTIGATIVE REVIEW**

### **1. 15-38, In Re: Alan Mafara, D.V.M.**

Dr. Mafara was present and made statements. After discussion and consideration, a motion was made by Dr. Bertch-Mumaw and seconded by Ms. Young to disagree with the Investigative Committee's recommendation and **dismiss** this issue with no violation. Motion passed unanimously. (Dr. Wright recused).

### **2. 15-44, In Re: Melissa Malone, D.V.M.**

Attorney, David Stoll, was present to monitor. After discussion and consideration, a motion was made by Dr. Hatfield and seconded by Mr. Loughead to accept the Investigative Committee's recommendation and **dismiss** this issue with no violation but issue a **Letter of Concern** with respect to communication with pet owners regarding extraction of teeth; written consent was not obtained nor was there an attempt to contact the pet owner. Motion passed 7 ayes, 1 nay (Dr. Serbin).

### **3. 15-45, In Re: Danielle Munoz, D.V.M.**

Attorney, David Stoll, was present to monitor. After discussion and consideration, a motion was made by Dr. Wright and seconded by Dr. Serbin to disagree with the Investigative

Committee's recommendation and **dismiss** this issue with no violation. Motion passed unanimously.

**4. 15-46, In Re: Gary Yocham, D.V.M.**

Attorney, David Stoll, was present to monitor. Complainant, Mr. Rendon, was present and made statements. After discussion and consideration, a motion was made by Dr. Hatfield and seconded by Ms. Young to schedule this matter for an **Informal Interview**. Motion passed unanimously.

**5. 15-47, In Re: Mario Tascon, D.V.M.**

Attorney, David Stoll, was present to monitor. Complainant, Mr. Rendon, was present and made statements. After discussion and consideration, a motion was made by Dr. Bertch-Mumaw and seconded by Dr. Hatfield to schedule this matter for an **Informal Interview**. Motion passed unanimously.

**6. 15-48, In Re: Paul Barrett, D.V.M.**

Attorney, David Stoll, was present to monitor. Complainant, Mr. Rendon, was present and made statements. After discussion and consideration, a motion was made by Dr. Bertch-Mumaw and seconded by Dr. Hatfield to accept the Investigative Committee's recommendation and **dismiss** this issue with no violation. Motion passed unanimously.

**7. 15-49, In Re: John McWhirter, D.V.M.**

Attorney, David Stoll, was present to monitor. After discussion and consideration, a motion was made by Dr. Hatfield and seconded by Ms. Young to accept the Investigative Committee's recommendation and **dismiss** this issue with no violation but issue a **Letter of Concern** with respect to the use of a long-acting steroid as a potentially inappropriate medical treatment. Motion passed, 6 ayes, 1 nay (Dr. Christensen).

**8. 15-50, In Re: Nicolette Gamez, D.V.M.**

Attorney, David Stoll, was present to monitor. After discussion and consideration, a motion was made by Ms. Young and seconded by Dr. Bertch-Mumaw to accept the Investigative Committee's recommendation and **dismiss** this issue with no violation. Motion passed unanimously.

**9. 15-51, In Re: Veronica Spencer, D.V.M.**

Attorney, David Stoll was present and read a statement from Dr. Spencer. After discussion and consideration, a motion was made by Dr. Serbin and seconded by Dr. Hatfield to schedule this matter for an **Informal Interview**. Roll call: Dr. Hatfield, aye; Mr. Loughead, aye; Dr. Bertch-Mumaw, nay; Dr. Serbin, aye; Dr. Wright, nay; Ms. Young, aye; and Dr. Christensen, nay. Motion passed 4 ayes, 3 nays.

**10. 15-71, In Re: Amanda Holland, D.V.M.**

After discussion and consideration, a motion was made by Mr. Loughead and seconded by Dr. Bertch-Mumaw to find Dr. Holland in **violation** of:

- A.R.S. § 32-2232 (12) as it relates to A.A.C. R3-11-204 (C)(1)(c) and (e)(i-v);
- A.R.S. § 32-2232 (13); and
- A.R.S. § 32-2232 (14).

The Board voted to offer Dr. Holland a Consent Agreement for the above violations; the **Consent Agreement** is to include a civil penalty of **\$500** to be paid within 60 days. Roll call:

Dr. Hatfield, nay; Mr. Loughead, aye; Dr. Bertch-Mumaw, aye; Dr. Serbin, aye; Dr. Wright, aye; Ms. Young, nay; and Dr. Christensen, aye. Motion passed 5 ayes, 2 nays.

#### **11. 15-70, In Re: Terri O'Rourke, D.V.M.**

After discussion and consideration, a motion was made by Dr. Serbin and seconded by Dr. Hatfield to find Dr. O'Rourke in **violation** of A.R.S. § 32-2232 (18) as it relates to A.A.C. R3-11-901 (B) for failure to respond to a Board complaint within fifteen (15) days as required. The Board voted to offer Dr. O'Rourke a Consent Agreement; the **Consent Agreement** is to include a civil penalty of **\$1000** to be paid within 60 days. Roll call: Dr. Hatfield, aye; Mr. Loughead, aye; Dr. Bertch-Mumaw, aye; Dr. Serbin, aye; Dr. Wright, aye; Ms. Young, aye; and Dr. Christensen, aye. Motion passed unanimously.

### **III. INFORMAL INTERVIEWS AND BOARD DELIBERATION**

#### **1. 15-35, In Re: Walter Kurth, D.V.M.**

After discussion and consideration, a motion was made by Dr. Hatfield and seconded by Dr. Serbin to issue Dr. Kurth a **Letter of Concern** with respect to the failure to understand hepatobiliary diseases and diagnostics associated with them. Motion passed 3 ayes, 2 nays (Dr. Wright and Dr. Christensen) and 1 abstention (Ms. Young).

After discussion and consideration, a motion was made by Dr. Hatfield and seconded by Dr. Serbin to find Dr. Kurth in violation of A.R.S. § 32-2232 as it relates to A.A.C. R3-11-501 (1) for failure to effectively communicate with the pet owner. After further discussion and consideration Dr. Hatfield and Dr. Serbin rescinded their motion.

After discussion and consideration, a motion was made by Dr. Hatfield and seconded by Dr. Serbin to find Dr. Kurth in violation of **A.R.S. § 32-2232 (18)** as it relates to **A.A.C. R3-11-901 (B)** for failure to respond to a Board complaint within fifteen (15) days as required. Roll call: Dr. Hatfield, aye; Mr. Loughead, aye; Dr. Bertch-Mumaw, aye; Dr. Serbin, aye; Dr. Wright, aye; Ms. Young, abstained; and Dr. Christensen, aye. Motion passed 6 ayes, 1 abstention.

After discussion and consideration, a motion was made by Dr. Hatfield and seconded by Dr. Serbin to find Dr. Kurth in violation of A.R.S. § 32-2232 (21) as it relates to A.A.C. R3-11-502:

- (L)(4) for failure to record in the medical record results of examination, including temperature, heart rate, respiration rate and general condition of the cat on November 5th and 6th while hospitalized for fluid therapy and treatment;
- (L)(7) (a) failure to record the concentration the Penicillin administered to the cat on November 4th, 5th and 6th; and
- (L)(7)(b) failure to record the amount of IV fluids administered to the cat during hospitalization.

Roll call: Dr. Hatfield, aye; Mr. Loughead, aye; Dr. Bertch-Mumaw, nay; Dr. Serbin, aye; Dr. Wright, nay; Ms. Young, abstained; and Dr. Christensen, nay. **Motion failed 3 ayes, 3 nays, 1 abstention.**

After further discussion and consideration, a motion was made by Dr. Hatfield and seconded by Dr. Serbin to find Dr. Kurth in violation of **A.R.S. § 32-2232 (21)** as it relates to **A.A.C. R3-11-502:**

- **(L)(4)** for failure to record in the medical record results of examination, including temperature, heart rate, respiration rate and general condition of the cat on

November 5th and 6th while hospitalized for fluid therapy and treatment;

- **(L)(7)(a)** failure to record the concentration the Penicillin administered to the cat on November 4th, 5th and 6th; and
- **(L)(7)(b)** failure to record the amount of IV fluids administered to the cat during hospitalization.

Roll call: Dr. Hatfield, aye; Mr. Loughhead, aye; Dr. Bertch-Mumaw, aye; Dr. Serbin, aye; Dr. Wright, aye; Ms. Young, abstained; and Dr. Christensen, aye. Motion passed 6 ayes, 1 abstention.
