#### **II. INITIAL INVESTIGATIVE REVIEWS**

After discussion and consideration, a motion was made by Dr. Wright and seconded by Dr. Heinrich to adopt Factual Allegations 1 through 9 in the Complaint and Notice of Hearing as the Board's Findings of Fact. Roll call: Ms. Creager, aye; Ms. Soloman, aye; Dr. Wright, aye; Mr. Loughhead, aye; Dr. Heinrich, aye; and Dr. Jaynes, aye. Motion passed unanimously.

After discussion and consideration, a motion was made by Dr. Wright and seconded by Ms. Soloman to adopt the Allegations of Unprofessional Conduct 1 through 3 as the Board's Conclusions of Law. Roll call: Ms. Creager, aye; Ms. Soloman, aye; Dr. Wright, aye; Mr. Loughhead, aye; Dr. Heinrich, aye; and Dr. Jaynes, aye. Motion passed unanimously.

After discussion and consideration, a motion was made by Dr. Wright and seconded by Ms. Soloman to **revoke** Dr. Rowand's veterinary license. Roll call: Ms. Creager, aye; Ms. Soloman, aye; Dr. Wright, aye; Mr. Loughhead, aye; Dr. Heinrich, aye; and Dr. Jaynes, aye. **Motion passed unanimously.**

#### V. ADMINISTRATIVE REVIEW OF PREVIOUS ACTIONS

Dr. Delano was present, made statements and answered questions in compliance with her Consent Agreement.

- At 10:19am, the Board entered back into open session.

After discussion and consideration, a motion was made by Ms. Soloman and seconded by Dr. Heinrich to offer Dr. Roy an Interim Consent Agreement (ICA) suspending Dr. Roy's license until a comprehensive evaluation could be performed based on Dr. Faria's

recommendations. The results of the comprehensive evaluation will be presented to the Board for further action. If the ICA is not signed in 10 days and the evaluation performed within 60 days, the matter will be remanded to Formal Hearing. Roll call: Ms. Creager, nay; Ms. Soloman, aye; Dr. Wright, nay; Mr. Loughead, nay; Dr. Heinrich, nay; and Dr. Jaynes, nay. **Motion failed 5 nays, 1 aye.**

After further discussion and consideration, a motion was made by Dr. Wright and seconded by Dr. Jaynes to offer Dr. Roy an **ICA** to undergo a **comprehensive evaluation** as recommended by Dr. Faria based on her evaluation; during this time Dr. Roy would be prohibited from providing veterinary medical services to publicly owned animals. Additionally, Dr. Roy shall cause her immediate supervisor to inform the Board, in writing, acknowledgement of the ICA with confirmation that they will be reviewing any reports/medical recommendations, etc. generated by Dr. Roy. If the ICA is not signed in 10 days and the comprehensive evaluation in 60 days, the matter shall be remanded to a Formal Hearing. The Board shall obtain the results of the comprehensive evaluation and may take further action based on those results. Roll call: Ms. Creager, aye; Ms. Soloman, nay; Dr. Wright, aye; Mr. Loughead, aye; Dr. Heinrich, aye; and Dr. Jaynes, aye. **Motion passed 5 ayes, 1 nay.**

**3.19-29: In Re: Julie Yeager, DVM. Board may review, discuss, and take action on completion of continuing education as required by Board Order and may return license to Active status.**

After discussion and consideration, a motion was made by Dr. Heinrich and seconded by Dr. Wright to approve Dr. Yeager's completed CE in compliance with her Board Order and return her license to Active status. Motion passed unanimously.


