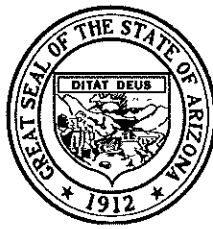

I. CALL TO ORDER

Roll call: Ms. Victoria Whitmore at 8:34am.

II. INITIAL INVESTIGATIVE REVIEW AND ACTION ON THE FOLLOWING CASES

1. 23-63, In Re: Carol Yeisley, VMD

Attorney David Stoll was present to monitor. After discussion and consideration, a motion was made by Ms. Frost and seconded by Mr. Loughead to accept the Investigative Committee's recommendation and **dismiss** this issue with no violation. Motion passed unanimously.

2. 23-66, In Re: Cara Wynne, DVM

Attorney David Stoll was present to monitor. Ms. Autumn Dossey was present and made statements. After discussion and consideration, a motion was made by Dr. Nausley and seconded by Mr. Loughead to accept the Investigative Committee's recommendation and **dismiss** this issue with no violation. Motion passed unanimously.

3. 23-67, In Re: Amy Gassman, DVM

Attorney David Stoll was present to monitor. After discussion and consideration, a motion was made by Dr. Thompson and seconded by Ms. Soloman to accept the Investigative Committee's recommendation and **dismiss** this issue with no violation. Motion passed unanimously.

4. 23-68, In Re: Megan Begay, DVM

Attorney David Stoll was present to monitor. After discussion and consideration, a motion was made by Dr. Thompson and seconded by Ms. Soloman to accept the Investigative Committee's recommendation and **dismiss** this issue with no violation. Motion passed unanimously.

5. 23-69, In Re: Teg Sidhu, BVSc

After discussion and consideration, a motion was made by Dr. Thompson and seconded by Ms. Soloman to accept the Investigative Committee's recommendation and **dismiss** this issue with no violation. Motion passed unanimously.

6. 23-70, In Re: Jessica Schneider, DVM

Attorney David Stoll was present to monitoring. Ms. Bertha Nichols was present and made statements. After discussion and consideration, a motion was made by Ms. Frost and seconded by Dr. Nausley to accept the Investigative Committee's recommendation and **dismiss** this issue with no violation. Motion passed unanimously.

7. 23-71, In Re: Kelly Patriquin, DVM

Ms. Bertha Nichols was present and made statements. After discussion and consideration, a motion was made by Ms. Frost and seconded by Dr. Nausley to accept the Investigative Committee's recommendation and **dismiss** this issue with no violation. Motion passed unanimously.

8. 23-72, In Re: Simon Escalada, DVM

After discussion and consideration, a motion was made by Dr. Thompson and seconded by Ms. Soloman to schedule this matter to an **Informal Interview**. Additionally, Dr. Escalada is ordered to undergo a **physical and psychological evaluation** to ensure he can safely and competently practice veterinary medicine. Dr. Escalada shall obtain an appointment within 30 days and have the results to the Board prior to the Informal Interview. Motion passed unanimously.

9. 23-73, In Re: Stephen Gilson, DVM

After discussion and consideration, a motion was made by Ms. Frost and seconded by Ms. Soloman to offer Dr. Gilson a **Consent Agreement** accepting the Findings of Fact as drafted. Motion passed 5 ayes, 1 nay (Mr. Loughhead).

After further discussion and consideration, a motion was made by Ms. Frost and seconded by Ms. Soloman to offer Dr. Gilson a Consent Agreement modifying the Investigative Committee's proposed Conclusions of Law and find Dr. Gilson in violation of:

- A.R.S. § 32-2232 (21) as it relates to A.A.C. R3-11-502:
 - (H) (1) failure to obtain signed authorization from the animal owner prior to general anesthesia;
 - (L) (4) failure to document in the medical record the examination of the dog on 12/1/22;
 - (L) (7) (d) failure to document in the medical record the route of administration for the butorphanol (12/1/22) administered to the dog; and
 - (M) (1 – 4) failure to properly label the radiographs taken of the dog.

Motion passed 5 ayes, 1 nay (Mr. Loughhead).

After discussion and consideration, a motion was made by Ms. Frost and seconded by Ms. Soloman to offer Dr. Gilson a Consent Agreement that including a period of **Probation of 1-year** to obtain **five (5) hours of continuing education in Medical Record Keeping**. If not signed in 30 days the matter will be scheduled to an Informal Interview. Motion passed 5 ayes, 1 nay (Mr. Loughead).

10. 23-74, In Re: Melissa Johnson, DVM

Attorney David Stoll was present to monitor. After discussion and consideration, a motion was made by Dr. Thompson and seconded by Dr. Nausley to modify the Investigative Committee's recommendation and dismiss this issue with no violation and issue a **Letter of Concern** with respect to post-op procedures and ensuring that patients are evaluated by a veterinarian prior to discharge. Motion passed 5 ayes, 1 nay (Ms. Soloman).

11. 23-129, In Re: Kayla Garard, CVT

After discussion and consideration, a motion was made by Mr. Loughead and seconded by Ms. Frost to adopt the findings in Investigative Memo as the Board's Findings of Fact. Motion passed unanimously

After further discussion and consideration, a motion was made by Mr. Loughead and seconded by Ms. Soloman to find Ms. Garard in violation of:

- A.R.S. § 32-2250 (2) and (4) as it relates to A.A.C. R3-11-105 (B) (3) and (5) failure to pay issuance fee for her veterinary technician certificate; and
- A.R.S. § 32-2247 as it relates to A.A.C. R3-11-607 (A) (1) (a) for failure to notify the Board of a change of address or employment.

After discussion and consideration, a motion was made by Mr. Loughead and seconded by Ms. Soloman to offer Ms. Garard a **Consent Agreement** that includes a Stayed Suspension until **civil penalty/issuance fees totaling one hundred dollars (\$100)** is paid (\$50 civil penalty; \$25 issuance fee; and \$25 delinquency fee). Fees shall be paid within 60 days of the effective date of the Consent Agreement. If Consent Agreement is not signed within fifteen days (15), the matter will be scheduled for an Informal Interview. Roll call: Dr. Thompson, aye; Ms. Soloman, aye; Mr. Loughead, aye; Ms. Creager, aye; Dr. Nausley, aye; and Ms. Frost, aye. Motion passed unanimously.

12. 23-130, In Re: Beatrice Vargas-Soto, CVT

After discussion and consideration, a motion was made by Mr. Loughead and seconded by Ms. Soloman to **dismiss** this issue with no violation and add a **letter to Ms. Vargas-Soto's file** that an issuance fee and delinquency fee is owed. Should she ever reapply for certification, these factors shall be considered and further action may be taken. Motion passed unanimously.

13. 23-132, In Re: Breonna Carey, CVT

After discussion and consideration, a motion was made by Mr. Loughead and seconded by Ms. Soloman to **dismiss** this issue with no violation and add a letter to Ms. Carey's file that an issuance fee and delinquency fee is owed. Should she ever reapply for certification, these factors shall be considered and further action may be taken. Motion passed unanimously.

14. 23-139, In Re: Mark Caldwell, DVM

After discussion and consideration, a motion was made by Ms. Frost and seconded by Dr. Nausley to **dismiss** this issue with no violation. Motion passed unanimously.

15. 23-140, In Re: Ivory Wildflower, DVM

Dr. Thompson was recused. After discussion and consideration, a motion was made by Mr. Loughead and seconded by Ms. Soloman to adopt the Investigative Division Report and Inspection Report as the Board's Findings of Fact. Motion passed unanimously.

After discussion and consideration, a motion was made by Mr. Loughead and seconded by Ms. Soloman to find Dr. Wildflower in violation of:

- A.R.S. § 32-2232 (21) as it relates to A.A.C. R3-11-502 (K) (2) and (3) failure to maintain adequate controlled substance logs;
- A.R.S. § 32-2232 (21) as it relates to A.A.C. R3-11-502 (L) (7) failure to consistently document medication routes, concentrations and amounts;
- A.R.S. § 32-2232 (21) as it relates to A.A.C. R3-11-502 (H) (3) failure to consistently document heart rate and respiration rate every 15 minutes while a pet is under anesthesia;
- A.R.S. § 32-2232 (18) as it relates to A.A.C. R3-11-502 (J) (2) expired pharmacy items on premises; and
- A.R.S. § 32-2274 (2) as it relates to A.A.C. R3-11-703 (4) failure to consistently maintain a premises in a clean condition.

Motion passed 5 ayes, 1 recusal (Dr. Thompson).

After further discussion and consideration, a motion was made by Mr. Loughead and seconded by Ms. Soloman to offer Dr. Wildflower a **Consent Agreement** that includes a period of **Probation for 1-year** to obtain **seven (7) hours of continuing education** in addition to the statutory requirements to maintain licensure. Those seven (7) hours shall be in the area of:

- 4 hours in Medical Record Keeping/Inventory Management; and
- 3 hours in Controlled Substances.

The Consent Agreement shall also include a **civil penalty of five hundred dollars (\$500)** to be paid on or before the end of the Probationary period. If the Consent Agreement is not signed in fifteen (15) days, the matter will be scheduled for an Informal Interview. Roll call: Dr. Thompson, recused; Ms. Soloman, aye; Mr. Loughead, aye; Ms. Creager, aye; Dr. Nausley, aye; and Ms. Frost, aye. Motion passed 5 ayes, 1 recusal.

After discussion and consideration, the Board directed staff to conduct a follow up premises inspection within 12 months and refer the issue of no controlled substance logs to DEA.

16. 23-141, In Re: Samuel Hollister, DVM

After discussion and consideration, a motion was made by Ms. Soloman and seconded by Mr. Loughead to offer Dr. Hollister a **Consent Agreement** adopting the proposed Findings of Fact as the Board's Findings of Fact and finding Dr. Hollister in violation of:

- A.R.S. § 32-2232 (18) as it relates to AAC R3-11-204 (D) with respect continuing to practice veterinary medicine after his license had lapsed.

The Consent Agreement shall include a **civil penalty of three hundred dollars (\$300)**, \$100 for each month Dr. Hollister practiced veterinary medicine without a license. If the Consent Agreement is not signed in fifteen (15) days, the matter shall be scheduled for an Informal Interview. Roll call: Dr. Thompson, aye; Ms. Soloman, aye; Mr. Loughead, aye; Ms. Creager, aye; Dr. Nausley, aye; and Ms. Frost, aye. Motion passed unanimously.

17. 23-145, In Re: Carolyn Hogan, DVM

Attorney David Stoll was present to monitor. After discussion and consideration, a motion was made by Ms. Soloman and seconded by Mr. Loughead to **dismiss** this issue with no violation. Motion passed unanimously.

III. INFORMAL INTERVIEWS - BOARD DELIBERATION AND ACTION

1. 23-47, In Re: Kimberly Young, DVM

Dr. Young was present with attorney David Stoll, made statements and answered questions. Mr. and Mrs. Jim Knuerr were present, made statements and answered questions. Dr. Anne Flessner was present made statements and answered questions. Ms. Brooke Joe was present, made statements and answered questions. After discussion and consideration, a motion was made by Dr. Nausley and seconded by Ms. Soloman to find Dr. Young in violation of:

- **A.R.S. § 32-2232 (11)** gross negligence:
 - Failure to properly evaluate the patient prior to assigning a low risk designation resulting in a deficient anesthetic plan;
 - Failure to properly supervise technical staff in the performance of the anesthetic plan; and
 - Failure to timely establish an airway following the appearance of fluid and the patient awakening.

Roll call: Dr. Thompson, aye; Ms. Soloman, aye; Mr. Loughead, nay; Ms. Creager, aye; Dr. Nausley, aye; and Ms. Frost, nay. Motion passed 4 ayes, 2 nays.

2. 23-98, In Re: Antonia Ronan, CVT

Ms. Ronan was present with attorney Cody Hall, made statements and answered questions. Mr. Adrian Castro was present. After discussion and consideration, a motion was made by Ms. Frost and seconded by Mr. Loughead to **dismiss** this issue with no violation. Motion passed unanimously.

3. 23-60, In Re: Vicki Harris, DVM

Dr. Harris was present with attorney Cynthia Patane, made statements and answered questions. Ms. Chelsea McGuire was present, made statements and answered questions. After discussion and consideration, a motion was made by Dr. Nausley and seconded by Mr. Loughead to find Dr. Harris in violation of:

- **A.R.S. § 32-2232 (12)** as it relates to **A.A.C. R3-11-501 (1)** failure to follow professionally acceptable procedures and use current professional and scientific knowledge by not performing VD radiographs on the barium series on 11/29/22;
- **A.R.S. § 32-2232 (12)** as it relates to **A.A.C. R3-11-501 (1)** failure to provide courteous verbal interchange by failing to communicate with pet owner during or after the dog's hospitalization on 11/29/22; and
- **A.R.S. § 32-2232 (21)** failure to maintain adequate records of veterinary services provided.

Motion passed unanimously.

After further discussion and consideration, a motion was made by Dr. Nausley and seconded by Dr. Thompson to find Dr. Harris in violation of:

- **A.R.S. § 32-2232 (11) Malpractice:**

- o Failure to recognize free barium in the abdomen on the final barium series radiograph 11/29/22 resulting in a misdiagnosis which resulted in delayed treatment of the patient; and
- o Failure to provide proper care to a critically ill patient.

Motion passed unanimously.

4. 23-61, In Re: Christopher Dorto, DVM

Dr. Dorto was present with attorney Rae Richardson, made statements and answered questions. Ms. Chelsea McGuire was present and made statements. After discussion and consideration, a motion was made by Dr. Nausley and seconded by Ms. Soloman to find Dr. Dorto in violation of:

- **A.R.S. § 32-2232 (12)** as it relates to **A.A.C. R3-11-501 (1)** failure to follow professionally acceptable procedures and use current professional and scientific knowledge by not performing a VD radiograph on 11/30/22;
- **A.R.S. § 32-2232 (12)** as it relates to **A.A.C. R3-11-501 (1)** failure to provide courteous verbal interchange by failing to communicate with pet owner on 11/30/22;
- **A.R.S. § 32-2232 (21)** failure to maintain adequate records of veterinary services provided.

Motion passed unanimously.

After further discussion and consideration, a motion was made by Dr. Nausley and seconded by Ms. Soloman to find Dr. Dorto in violation of:

- **A.R.S. § 32-2232 (11) Malpractice:**
 - o Failure to recognize free barium in the abdomen on the final barium series radiograph on 11/29/22 and 11/30/22 resulting in a misdiagnosis which resulted in delayed treatment of the patient; and
 - o Failure to treat a critically ill patient on 11/30/22.

Motion passed unanimously.

5. 23-62, In Re: Lorna Lanman, DVM

Dr. Lanman was present with attorney Leeza Birko, made statements and answered questions. After discussion and consideration, a motion was made by Dr. Nausley and seconded by Ms. Soloman to find Dr. Lanman in violation of:

- **A.R.S. § 32-2232 (12)** as it relates to **A.A.C. R3-11-501 (1)** failure to follow professionally acceptable procedures and use current professional and scientific knowledge by not performing a VD radiograph on 11/30/22;
- **A.R.S. § 32-2232 (12)** as it relates to **A.A.C. R3-11-501 (1)** failure to provide courteous verbal interchange by failing to communicate with pet owner after the reception area discussion and inappropriate conversation with the pet owner through text messages;
- **A.R.S. § 32-2232 (21)** failure for the premises maintain adequate records of veterinary services provided.

Motion passed unanimously.

After further discussion and consideration, a motion was made by Dr. Nausley and seconded by Ms. Soloman to find Dr. Lanman in violation of:

- **A.R.S. § 32-2232 (11) Malpractice:**
 - o Failure to recognize free barium in the abdomen on the final barium series radiograph 11/29/22 and 11/30/22 resulting in a misdiagnosis which resulted in delayed treatment of the patient; and

- o Failure to provide care to a critically ill patient on 11/30/22.
- Motion passed unanimously.

6. 23-122, In Re: Lorenzo Gonzales, DVM

Dr. Gonzales was present, made statements and answered questions. After discussion and consideration, a motion was made by Mr. Loughhead and seconded by Ms. Soloman to find Dr. Gonzales in violation of:

- **A.R.S. § 32-2274 (A) (2)** failure to maintain a clean and sanitary facility for the performance of services in accordance with the rules adopted by the Board; and
- **A.R.S. § 32-2274 (A) (5)** Failure to maintain veterinary medical supplies, controlled substances and surgical and other equipment in a safe, efficient and sanitary manner, as it relates to **A.A.C. R3-11-704 (2)** sterile surgical packs.

IV. ADMINISTRATIVE REVIEW OF PREVIOUS ACTIONS

1. Combined cases 22-136 & 23-03: In Re: Maya Bellapianta, DVM. Monthly appearance as required by Consent Agreement. Board may review, discuss, and take action on compliance with consent agreement and other information presented.

Dr. Bellapianta was present with attorney Flynn Carey, made statements and answered questions in compliance with her Consent Agreement.

2. 23-80: In Re: Dawn Hunsberger, VMD. Monthly appearance required by Interim Consent Agreement (ICA). Board may review, discuss, and take action on information presented regarding Dr. Hunsberger's compliance with the ICA. The Board's options include, but are not limited to, offering an amended ICA.

Dr. Nausley was recused. Dr. Hunsberger was present, made statements and answered questions in compliance with her Consent Agreement. Dr. Hunsberger's counselor has scheduled sessions every other week at this time due to their capacity constraints. The Board found that to be acceptable for the immediate future.

3. 23-16: In Re: Mary Ann Bolser, DVM. Board may review, discuss, and take action on Continuing Education completed in compliance with Consent Agreement and may return license to Active status.

After discussion and consideration, a motion was made by Ms. Creager and seconded by Dr. Thompson to accept Dr. Bolser's completed continuing education in compliance with her Consent Agreement and return her license back to **Active** status. Motion passed unanimously.

4. 23-89: In Re: Jessica Muniga, DVM. Board may review, discuss, and take action on Consent Agreement.

After discussion and consideration, a motion was made by Mr. Loughhead and seconded by Ms. Soloman to **dismiss** this issue with no violation and add a letter to Dr. Muniga's file that issuance fee and delinquency fees are owned. Should she ever reapply for licensure, these factors shall be considered and further action may be taken. Motion passed unanimously.

5. 23-27: In Re: Rose Fiskett, VMD. Board may review, discuss, and take action on Continuing Education plan submitted in compliance with Board Order.

After discussion and consideration, a motion was made by Mr. Loughead and seconded by Ms. Creager to accept Dr. Fiskett's continuing education plan submitted in compliance with her Board Order. Motion passed unanimously.
