After discussion and consideration, a motion was made by Dr. Wright and seconded by Dr. Bertch-Mumaw to **dismiss** this issue with no violation. Motion passed 6 ayes, 1 nay (Ms. Frost), 1 absent and 1 recusal.

Dr. Zetye was present, made statements and answered questions. Mr. William Stevens was present, made statements and answered questions. After discussion and consideration, a motion was made by Dr. Heinrich and seconded by Ms. Amend to dismiss this matter and

issue a **Letter of Concern** for the use of meloxicam without performing blood work prior and the inefficient use of medical records to clearly state what services the pet owner declined. Motion passed 8 ayes, 1 absent.

3. 16-46 and 16-54: In Re: Walter Kurth, DVM

16-46: Dr. Kurth was present telephonically, made statements and answered questions. After discussion and consideration, a motion was made by Dr. Hatfield and seconded by Dr. Wright to find Dr. Kurth in **violation** of:

- **A.R.S. § 32-2232 (12)** as it relates to **A.A.C. R3-11-501 (1)** failure to provide professionally acceptable procedures for not completing the neuter procedure.
- **A.R.S. § 32-2232 (21)** as it relates to **A.A.C. R3-11-502:**
 - **(L) (7) (a)** failure to document in the medical record the concentration of ketamine, valium, atropine and pen G administered to the dog on November 23, 2015;
 - **(L) (8)** failure to document in the medical record the antibiotics dispensed to the dog on January 14, 2016; and
 - **(H) (3)** failure to document in the medical record the animal's heart rate and respiration rate every 15 minutes while anesthesia is being administered on November 23, 2015.

Motion passed 8 ayes, 1 absent.

16-54: Dr. Kurth was present telephonically, made statements and answered questions. Ms. Lynn Sharp was present, made statements and answered questions. After discussion and consideration, a motion was made by Dr. Hatfield and seconded by Dr. Bertch-Mumaw to find Dr. Kurth in **violation** of:

- **A.R.S. § 32-2232 (12)** as it relates to **A.A.C. R3-11-501 (1)** for failure to provide professionally acceptable procedures for using a surgery light that has a known potential to burn a patient without the filter.
- **A.R.S. § 32-2232 (21)** as it relates to **A.A.C R3-11-502 (L) (7) (a)** for failure to document the concentration of atropine and pen G administered to the dog on October 12, 2015.
- **A.R.S. § 32-2232 (21)** as it relates to **A.A.C R3-11-502 (L):**
 - **(3)** failure to document the date in the medical record when pain medication was dispensed during the post-surgical period; and
 - **(8)** failure to document in the medical record the pain medication prescribed during the post-surgical period.
- **A.R.S. § 32-2232 (11) Gross negligence;** injury and unnecessary suffering that was caused by the careless use of a surgical light without the filter in place.

Motion passed 8 ayes, 1 absent.

After discussion and consideration, a motion was made by Dr. Hatfield and seconded by Dr. Wright to combine these cases with case 16-89 and schedule this matter to a **Formal Hearing** adding potential violation **A.R.S. 32-2232 (6)** for case 16-46 to the complaint and notice of hearing to Dr. Kurth. Motion passed 8 ayes, 1 absent (see II. #22).

4. 16-58: In Re: Arden Andersen, DVM. Continuance of Informal Interview of July 20, 2016, for the purpose of receiving additional information and reviewing and possible action to approve proposed Findings of Fact, Conclusions of Law and adopting an Order.

After discussion and consideration, a motion was made by Dr. Bertch-Mumaw and seconded by Ms. Amend to approve the Findings of Fact and Conclusions of Law as drafted. Motion passed 8 ayes, 1 absent.

After further discussion and consideration, a motion was made by Dr. Bertch-Mumaw and seconded by Dr. Heinrich to issue Dr. Andersen an Order to include a period of Probation for 1-year to complete four (4) hours of continuing education in addition to the statutory requirements for licensure. 
